Why are we having our last meeting the first week of the season?

- -technology has been a game-changer, as far as getting information to the masses, as well as getting questions answered
- -the debriefs are helping to alleviate the need for face-to-face meetings to clarify rules

Situations:

- -Lee's Summit High fieldhouse court has illegal markings for attack lines; must have a solid attack line; take a picture, email it to Davine at MSHSAA, CC: Dixie Wescott and Don Sleet; play the match!
- -Coach was told her girls could not stand behind bench to stretch; bench players need to stay seated except for situation stated in Rule 12-2-7c; bench personnel must be seated at all times, except to cheer

Concussion video

- -also available on MSHSAA website; links will be on Ken's GKCOA volleyball page
- -according to the video, most of the responsibility is on the part of the school
- -once a player has been removed for a suspected concussion, she is not allowed to be put back in the contest until she has been cleared by a health care professional
- -according to rule 10-3-5, the R1 has the prerogative to take the player out if they are confident the player has been concussed, IF the coach has not taken the initiative
- -officials DO NOT evaluate the player; if you overhear slurred speech, observe other symptoms, you may suggest to the coach
- -play is stopped, official indicates to coach, R2 times injury time-out
- -needs to be noted in the scorebook, go ahead and fill out a Special Report to MSHSAA

- -line up check leads to pre-set sub
- -overlap

- -mistaken sub leads to adm delay yellow card
- -R1, R2 responsibilities

N2 Sports also broadcasts their volleyball matches on YouTube if you want to observe

Assignor announcements:

Confirm matches and information with schools at least 5 days in advance

Check Arbiter every day during the season!

Open dates-we need officials: 9/12, 10/1, 10/7, 10/9, 10/12, 10/19

Next year all varsity matches will be 3/5

- -may start doing this this season
- -ASK when you contact the school before the match
- -if you're line judging C team match and then line judging, when you call, ask if varsity is playing 3/5 or 2/3

How can you know when it is a Conference Match?

- -research, find the list of conferences and teams on Ken's GKCOA page
- -Crossroads Conference always plays 3/5 on varsity

GKCOA observation program:

Not an evaluation, just a way to observe and give some feedback

-as R1, slow down

Ball handling:

Is it getting better?

- -on doubles: did it go right to left or left to right?
- -ball watching v player watching: watch the ball for touches

Officiating club volleyball:

Denise Jett-USAV (Heart of America)

- -season starts right after high school season is over
- -must be rated, take clinics and exams at tournaments in Nov and Dec
- -Saturdays and Sundays, ALL DAY, R1
- -registration is already open

The Debrief:

- -5 min after each match and talk about anything that happened
- -compliment and critique situation, not the person
- -avoid defensive reaction and saying, "Yeah, but..."
- -thank partner for the feedback and do better next time!

Situations:

C team player needs to check blood sugar during match

-sub the player out until she is ready to come back in

In tournaments, head coaches are supposed to bring roster to EACH captains' meeting Pants for religious reasons are legal according to rule 4-2-1i

Head covering for religious reasons is in case book p 14; must have MSHSAA letter or not play

If your name is Referee 1 on tournament, don't schedule yourself for the 1st match
